RESOLUTION BY THE BOARD OF COMMISSIONERS OF WACO HOUSING AUTHORITY & AFFILIATES APPROVING THE 2026 ANNUAL PLAN FOR SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

WHEREAS, the Waco Housing Authority & Affiliates (the “Authority”) is required to submit an Annual Plan to the U.S. Department of Housing and Urban Development (HUD) pursuant to Section 5A of the United States Housing Act of 1937, as amended, and implementing regulations at 24 CFR Part 903; and

WHEREAS, the 2026 Annual Plan outlines the Authority’s mission, goals, objectives, and policies for serving the needs of low-income and very low-income families in its jurisdiction during the fiscal year; and

WHEREAS, the Authority has ensured the Annual Plan was developed in consultation with the Resident Advisory Board (RAB) and that a public hearing was duly held after providing the required 45-day public notice and opportunity for public comment, in accordance with HUD regulations; and

WHEREAS, the Board of Commissioners has reviewed the contents of the proposed 2026 Annual Plan and finds it to be in compliance with HUD’s requirements and consistent with the Authority’s mission and goals.

WHEREAS, this resolution was considered at a regular meeting open to the public as required by law and notice of the time, place and purpose of said meeting was given as required by Chapter 551 of the Texas Government Code:

NOW, THEREFORE, BE IT RESOLVED THAT that the Board of Commissioners of the Waco Housing Authority & Affiliates hereby approves the 2026 Annual Plan and authorizes its submission to the U.S. Department of Housing and Urban Development on this 11th day of June 2026, by the Board of Commissioners of the Waco Housing Authority & Affiliates.
